The City of Worland provides water services to out of city/non-residents. The minimum or base charge for out of city/non-residents is \$10.48 for Water, \$10.24 for EDU (rate varies per tap size) and for Sewer – rates vary per area (if applicable). The City of Worland reads water meters once per month and you are charged additional water fees for water used in addition to the base charge. All out of city/non-residents must haul their trash to the landfill. **The \$200.00 Deposit is non-interest bearing and will be credited to your account after one (1) complete year of utility payments being paid on or before the due date.** PLEASE NOTE: EDU AND SEWER CHARGES WILL CONTINUE TO ACCRUE EVEN IF WATER HAS BEEN TURNED OFF.
